New Membership Agreement

1. **Membership Stock Purchase:** Friendly Park, Inc. is a member-owned pool. All new members purchase one unit of membership stock at a cost of \$500. The stock purchase is a one-time cost and the stock fee can be refunded upon termination of membership. The stock fee of \$500 must be paid in full in order to join Friendly. You can pay the fee with a check payable to Friendly Park, Inc., with a credit card online or through a one-time bank draft.

2. **Dues:** Members pay dues annually and the amount of dues are annually set by the Board of Directors. We do offer different payment options for annual dues, you have the option to pay via bank draft over 4 months, 6 months or 12 months. Please note that each draft payment includes a processing fee of \$2.50. Members must pay dues in full or be enrolled in a draft plan on or before May 1st each year to avoid late fees. The schedule of late fees can be found in the By-Laws of Friendly Park, Inc.

2. Payment in full of Membership Payment Plan;
3. Agreement to abide by the By-Laws of Friendly Park, Inc. and the General Rules & Regulations promulgated by the Board of Directors of Friendly Park, Inc.

By affixing my signature below, I acknowledge and understand that this is a note of indebtedness and that I am personally obligating myself to make the foregoing payments at the schedule selected above. If I fail to make the foregoing payments at the schedule selected above within 30 days of the date said payment is due, I understand that I will be in default on my payment obligation. In the event of such a default, I further understand that Friendly Park, Inc. shall be entitled to retain the payments I have made and, at its election, to accelerate the remaining balance of the payments due and owing at the time of default for the initiation fee, stock and unpaid dues, and to sue to recover said balance plus interest at prevailing maximum legal rate and reasonable attorney's fees incurred to recover said balance. Failure by Friendly Park, Inc. to exercise its right to accelerate and sue on any remaining balance shall not be deemed to be a waiver of such default or Friendly Park, Inc.'s right to accelerate and sue on any remaining balance at a later time.
