vWise, Inc.'s PowerView email went out at the first of June! We told you about PowerView before. Remember this is a semi-annual email that goes out to plan participants every June 1st and December 1st. This email has a link to our login page. Participants just login and get up to date information on their accounts like current balance, projected benefit at age 65 as a total amount and as a monthly amount, and gives them pointed action steps they can take to improve their retirement outcome.

On the next page is what the email looks like. When this email goes out, participants can click on it and go to the login page. It's that simple!

- Future enhanced payroll file sharing options that we are working to develop. We hope to partner with payroll vendors soon to be able to assist you further in getting payroll data entered into our system.
- Updated browser capabilities Windows 7, 8, and 10 now support IE11, MS Edge, and Google Chrome 65+. OSx supports Safari 9+ and Google Chrome 65+. iOS9 supports Safari and Google Chrome 65+
- Distribution Dashboard we believe the best option is to continue to test the new functionality so that you get a clean and user-friendly dashboard. We'll share more details as we finish our internal testing and reviews. We will roll this out for a view of "lump sum" distributions. Therefore, partial withdrawals like Hardships will not be visible yet.

MVP's Form 5500 Completion Record

We are excited to provide the result of our IRS Form 5500 completion for the 2017 plan year-end filings. Here is a comparison of 2016 filings done in 2017 and 2017 filings done in 2018 through 7/31/18:

- 2016 5500s through 5/31/17 58% completed
- 2017 5500s through 5/31/18 43% completed

However,

- 2016 5500s through 7/31/17 78% completed
- 2017 5500s through 7/31/18 82% completed

Yes, we are cheating by jumping ahead to 7/31, but wanted to share the latest news! As you can see, MVP continued to be diligent throughout the filing period. We are proud of the dedication and devotion of our MVPers who take such great care of you!
